Christkindlmarkt is a traditional German Christmas Market that takes place in the evening during the Advent season. We hope to make this event a place of holiday jubilee for all. There will be a few changes this year, including time adjustments and changes due to COVID.

Friday December 11th from 5pm to 9pm

AND

Saturday December 12th from 9am to 4pm

The Historic Dills Tavern provides a unique setting for vendors and market goers to experience an age-old tradition just in time for the holiday season. Due to COVID this year, all spaces will be outdoors. We do not expect that the indoor spaces will be accessible due to COVID restrictions. Outdoor spaces are readily available and keep within the true experience of a Christkindlmarkt. Our recently paved parking lot and crushed gravel pathway will provide good access to additional spaces.

Outside spaces for vendors are approximately ten foot square allotments. Vendor spaces are **\$35 for one space** for both Friday and Saturday's Market. **Spaces will only be reserved once the contract and fees are received.** Additional spaces may be purchased at the same rate and will be adjacent. All items must be stored within the allotted space and no items may be placed outside of the space for safety purposes. Vendors must provide their own light, tables, and chairs. **Spaces are not lit** and will not have access to outlets. Vendors are asked to provide links to their social media so they can be used in advertising and can link to our site (<https://www.facebook.com/DillsTavern>). This is event proceeds **RAIN OR SHINE!**

FRIDAY, DECEMBER 13th: Setup begins at 2pm and the site opens at 5pm.

SATURDAY, DECEMBER 14th: The site is open to vendors at 8am and to the public at 9am.

Vendors are required to stay open until 4pm. Early breakdown for either day is prohibited for the sake of the event and to provide continuous shopping throughout the day.

Spaces will be assigned on a first come first served basis and **are at the discretion of NYCHAPS.**



VENDOR CONTRACT

The Vendor Agrees to the Following:

- Set-up and tear down promptly at the designated times on Friday and Saturday.
- A commitment to be present for the time slot the vendor reserves.
- Occupy only the space paid and reserved. Vendors will be strictly limited to a 10” space unless additional spaces have been purchased.
- Provide own tables, chairs, tents, lights, and all things necessary for a nice presentation.
